The executor and the attorney are each entitled to the fee shown on this page. If extraordinary services are performed by them, the court will allow a reasonable fee to each for those services.

Pursuant to Government Code section 68106, the Superior Court of California, County of Orange is providing a 60 day notice of the change in court location for Probate and Mental Health matters heard and documents filed at the Lamoreaux Justice Center, located at 341 The City Drive South, Orange, California 92868.

The financial constraints imposed by the California state fiscal crisis as well as the repeated decreases in state court funding compel this change in court location.

Effective Monday, July 1, 2013 all Probate and Mental Health cases will be transferred to and heard at the Central Justice Center located at 700 Civic Center Drive West, Santa Ana, California 92701. The Probate and Mental health clerk's office located on the first floor of the Central Justice Center in Santa Ana will process all Probate and Mental Health filings.

Additionally, the Name Change calendar currently heard in Department L73 of the Lamoreaux Justice Center will be transferred to Department C19 of the Central Justice Center effectively July 1, 2013.

The Adoption calendar currently heard in Department L53 of the Lamoreaux Justice Center will be transferred to Department L73 effective July 1, 2013.

NEW PROBATE CASE FILINGS

Effective April 8, 2013, except as to those cases that may be filed in the North District pursuant to LASC Local Rule 2.3 (a)(1)(B), all Los Angeles Superior Court probate cases (all actions and proceedings to which the Probate Code applies) must be filed in Room 429 in the Stanley Mosk Courthouse, located at 111 N. Hill St., Los Angeles 90012.

TRANSFER OF EXISTING PROBATE CASES

There will be no transfer of existing probate cases from the North District.

In all other districts, on June 10, 2013, all probate cases pending in district courthouses will be transferred to Department 29 in the Central District. Individual transfer notices for each reassigned case will be sent to the petitioning parties. The petitioner will be responsible for sending notice to any other parties. The date and time of the hearing will remain as currently set.
